#### **LC Net Focus**

### Base IMPACTS ® of ADEME, the French Environment and Energy Management Agency, is now available online

In the context of the French law aiming at an environmental labelling on consumer goods based on LCA indicators, the ADEME has been mandated to set up a national LCI/LCIA database.



In terms of format, ADEME's database is based on the JRC's ILCD Dataset format. Each process dataset is imported as an aggregated life cycle inventory (LCI) dataset and characterized through the methods recommended by the JRC, allowing the LCIA indicators to be released to the public.

In terms of content, two modes have been set up to feed the database in terms of LCI datasets: purchase (mode 1) and development (mode 2). A contribution mode (mode 3) remains to be set up.

Buildings are an important consumer of energy and an important source of greenhouse gas emissions. In the last decade buildings and their environmental impacts are getting more and more attention.

The discussion forum will provide an overview on different tools, information and labelling schemes, highlighting common aspects and main differences. The application of life cycle based information in the planning process is presented from the perspectives of building owners, practitioners and industry. The situation in neighbouring countries is described and the influence of the European Union's construction products' regulation on the current landscape of environmental tools and labels is discussed. Results from recent research projects are shown. Needs and expectations from the viewpoint of building owners, planners and architects, and suppliers, respectively will be discussed. The goal of the discussion forum is to support informed decisions about the most appropriate environmental information and labelling schemes for the coming decade.



### Flagship Activity Feedback - A selection

### Global Principles and Practices for Hotspots Analysis • Co-chairs Jim Fava and Mark Barthel

Phase 1 Hotspots Analysis flagship is making good progress. Since the survey that was launched in June, the results have been reviewed and analysed, with further support from desktop research and interviews with key hotspots analysis methodologies developers and users. The outcome of this work is being finalised in order to soon be launched as an official publication of the UNEP/SETAC Life Cycle Initiative and disseminated worldwide. A number of presentations have been made on the project during the last month including The Sustainability Consortium Member Conference and PEF World Forum Summit in Berlin, INLCA Conference, San Francisco, ILCM Conference, India, World Resources Forum Conference, Peru and Product Sustainability Forum Plenary Session, London. A lot of very useful and positive feedback has been received from these events. The next presentation will be at the City Food Symposium 2014 in London on 15 December.

The comment period for the Hotspot Analysis publication has been extended until Monday, November 17, 2014, in order to provide extra opportunity to review and provide comment on this report prior to publication. Click to consult the publication and provide feedback.

### Data and Database Management • Co-chairs Bruce Vigon and Guido Sonnemann

The flagship held a well-attended training workshop on Global Guidance Principles (GGP) on Life Cycle Assessment Data and Databases during the Indian Conference of Life Cycle Management (ILCM 2014) in New Delhi, India, 29-30 September 2014. The workshop was hosted by Federation of Indian Chambers of Commerce and Industry (FICCI) and well attended.

Based on the experiences of the workshop the training kit was updated for use at the next training workshop planned on 9 November in Sao Paulo, Brazil, organised back to back with the Brazilian LCM Conference, 10-12 November 2014.

The flagship leaders foresee to publish a final version of the training kit for public use early in 2015 and to organise an additional training workshop in South Africa also next year.

### Environmental Life Cycle Impact Assessment Indicators • Co-chairs Rolf Frischknecht and Olivier Jolliet

Phase 2 of the Environmental Life Cycle Impact Assessment Indicators flagship is progressing well. All Task Forces (Climate change, Respiratory inorganics, Land use, Water use and Cross-cutting issues) are currently evaluating approaches and methodologies in their field in view of their harmonisation potential. The Task Forces are targeting their activities towards a Pellston workshop scheduled for late 2015/early 2016. The Pellston workshop, a one week workshop with a given structure, format and ground rules in a remote venue, will help to achieve and formalize consensus around the topics mentioned above. The SETAC global Science Committee and World Council approved the concept of the workshop. Now, the planning of the workshop will be refined and potential venues and donors identified.

The UNEP/SETAC Life Cycle Initiative is very appreciative of the time and expertise of all members of the various Task Forces, which help fostering harmonisation.
