### Results for the Government constituency (1 seat)

One organisation nominated as a candidate, meaning that an election was not needed. The new elected government representative to the Steering Committee is:

- **United States – Department of Energy (DOE)**, Represented by: Gregory Cooney, Senior Engineer, Office of Carbon Management

The Steering Committee government representatives for 2022-2023 cycle are:

- European Commission – DG Environment (Europe) [mandate until 2023]
- NSTDA- Government of Thailand (Asia Pacific) [mandate until 2024]
- United States – Department Energy (DOE) [mandate until 2025]





## Results for the Business constituency (1 seat)

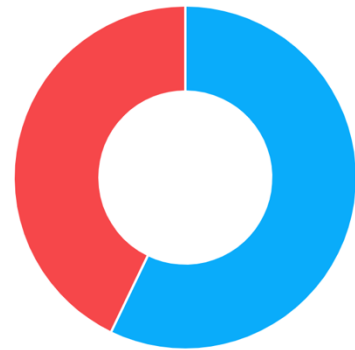
Two organisations nominated as candidates for the election. With 57% of the votes cast, the new business organisation elected to the Steering Committee is:

- Talent Upgrade Global Concept, Represented by: Michael Adedotun Oke, Nigeria

The Steering Committee business representatives for 2022-2023 cycle are:

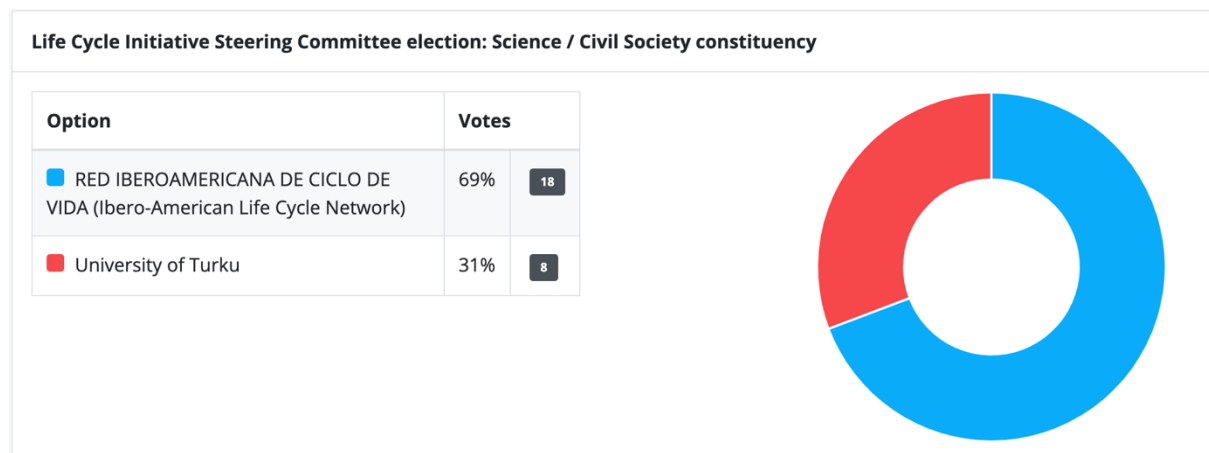
- EcolInnovazione (Europe) [mandate until 2023]

## Results for the Science and Civil Society constituency (1 seat)

Two organisations nominated as candidates for the election. With 69% of the votes cast, the new Science/Civil Society organisation elected to the Steering Committee is:
