Thank you also to all the Life Cycle Initiative members submitted their ballots in these elections.

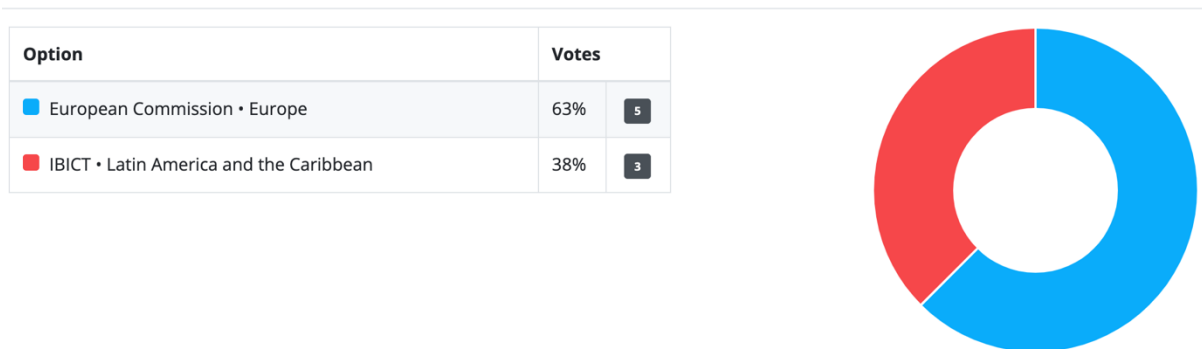
And now the results...

Results for the Government constituency (1 seat)

Two organisations nominated as candidates for the election. With 63% of the votes, the newly elected government representative to the Steering Committee is:

- **European Commission**, represented by Malgorzata Golebiewska.

- European Commission (Europe) [mandate until 2026]




Results for the Business constituency (1 seat)

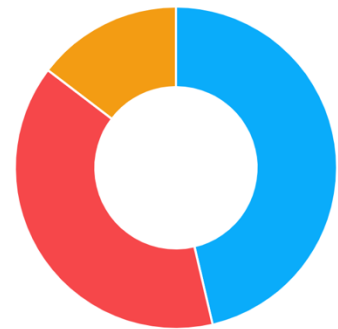
Two organisations nominated as candidates for the election. With 46% of the votes, the newly elected business organization representative to the Steering Committee is:

- Unilever (Europe) [mandate until 2026]

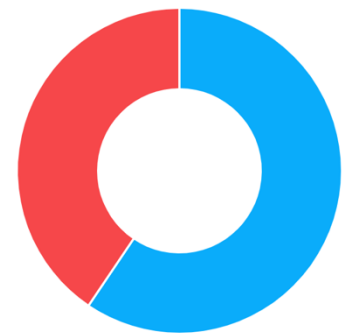
Results for the Science / Civil Society constituency (1 seat)
